

This first day of oversight hearings will be devoted to examination of the Food and Drug Administration, the second day to examination of the Environmental Protection Agency, and the concluding 2 days to examination of the Federal Reserve System. These hearings are very much in keeping with a tradition established by the subcommittee of holding hearings which examine the function, role, and purpose of administrative and regulatory agencies. While the subcommittee cannot ignore completely the substance of our policies with respect to either the food and drug industries, the environment, or monetary flow and economic stability, the major focus of these hearings will be administration of the various programs for which each agency has responsibility, the particular administrative procedures employed by each agency in implementing programs with emphasis on procedures used in formulating the rules, regulations, and...
